(57) **CLAIM**

I claim the ornamental design for a valve with angled flange, as shown and described.

DESCRIPTION

FIG. 1 is a front top perspective view of a valve with angled flange showing my new design;
 FIG. 2 is a rear bottom perspective view thereof;
 FIG. 3 is a front view thereof;
 FIG. 4 is a rear view thereof;
 FIG. 5 is a top view thereof;
 FIG. 6 is a bottom view thereof;
 FIG. 7 is a left side view thereof; and,
 FIG. 8 is a right side view thereof.

The broken lines shown in the figures are included for the purpose of illustrating portions of the valve with angled flange and form no part of the claimed design.
